

## V. Lesson Planning

---

Careful organization of each class meeting helps even experienced language instructors use their time more efficiently, anticipate many questions, and provide clear explanations. Detailed lesson plans minimize the amount of talking done by the instructor and maximize the opportunity for student practice.

### A. TEXTBOOK ADAPTATION

Individual instructors always know their own students better than any group of textbook authors can. For this reason, most instructors do not follow the textbook word for word, but instead emphasize the grammar points and language skills that seem most important for their language program. They select some exercises and activities for classroom practice, assign others to be prepared out of class, create their own variations of some materials, and omit others. This type of decision making is at the heart of good language teaching.

At first reading, it may seem contradictory for the authors of a foreign-language textbook to recommend the adaptation of—rather than the slavish use of—the text for effective language instruction, yet this is precisely their recommendation. Factors that make textbook adaptation a virtual necessity include the following:

- the reevaluation of course goals in elementary language courses
- curricular changes such as extending the first-year course over three semesters (four quarters)
- multiple sections of first-year courses, with different language goals in different sections
- the desire to incorporate supplementary materials (readers, video materials, and so on)
- insufficient class time to cover all of the material offered in the text

If instructors are in agreement with the underlying pedagogical assumptions of a first-year text (that is, if they believe that the language learning materials that the text contains truly help students learn a foreign language and are compatible with course goals), then almost any textbook can be adapted to meet the needs of a given problem.

With the increased emphasis on proficiency-oriented instruction, instructors will find readily available many fine books and articles on the topic of textbook adaptation. In addition, since the topic of textbook adaptation has become popular in recent years, attendees at local or national foreign-language conferences will often find sessions on the program about this topic. In particular, the ACTFL organization has been active in this area.

Perhaps the most common complaint about textbooks is that they cover too much material. Here again, instructors should feel free to adapt materials to fit their instructional needs. “Covers too much” may mean “presents too many grammar topics.” If this is the case, instructors should feel free to omit (or present for passive recognition only) grammar points that they feel are too detailed for first-year students. The omission of entire chapters is also another option. This recommendation is especially appropriate for language programs meeting three hours a week. Alternatively, many institutions choose to cover a beginning textbook over three semesters (or four quarters). There is no need to permit the textbook to define curricular goals, yet this is precisely what happens when “covering the text” or “covering ‘x’ chapters” is used as a synonym for “first-year Spanish.”

“Covers too much” can also mean “presents too many practice materials to be used in one’s academic program.” Again, textbook adaptation is the logical solution. *Puntos en breve* contains more material than can be used in most language programs. Some materials lend themselves quite well to out-of-class assignments. The abundance of materials has been included for a variety of reasons:

- to help novice instructors, who are less able to create supplementary materials needed for a given situation
- to provide instructors with a wide range of materials from which to choose
- to serve as supplementary materials for students who need more practice or who want to do more

It is the authors’ firm belief that providing *more* practice with *less* grammar is one of the keys to effective first-year language instruction, especially in four- (or five-) skills language programs. The text has been structured to serve as the basis for such programs.

## B. SYSTEMATIC LESSON PLANNING

Whereas some instructors are capable of teaching an excellent and engaging class off the top of their heads, most instructors—especially “new” teachers—cannot do so without substantial planning ahead of time. The following four-step approach details the issues that experienced language teachers think about implicitly or explicitly as they plan their classes. New or inexperienced teachers may wish to follow these steps carefully in planning their first classes.

### 1. Think Through What You Are Going to Teach

- a. What you want to accomplish (content)
- b. What students already know about the content
- c. How will you present new material
- d. What exercises and activities you will use and how you will use them
- e. How much time you need for each segment of the class

Be aware of how you sequence material. A typical sequence for new material would be presentation → drill practice → communicative practice.

When you present a new grammar topic, it may make sense to begin with a brief review of similar or related material. For example, review possession with **de** before introducing the unstressed forms of possessive adjectives in **Capítulo 2. (¿Recuerda Ud.?** sections and marginal notes in the *Instructor’s Edition* will alert you to such situations.) When introducing new material, strive for clear, concise explanations, and give several pertinent examples; it is a good idea to write down a few.

Exercises should also follow a sequence. Ideally, you would follow the presentation of new material with a very brief, focused exercise that tests students’ ability to use the new material. Easier exercises should precede more difficult ones, and exercises that are very controlled should precede the open-ended kind, in which students must be creative. The exercise materials in *Puntos en breve*, including those in the *Instructor’s Edition*, follow the sequence just described.

A typical class should also include a review of the previous day’s material, especially when new material has been presented, and a quick preview of new material for the following day. Review can be systematic, featuring grammar exercises, but it can also be a simple warm-up exercise at the beginning of the class, consisting of a few personalized questions that practice the vocabulary or grammar point emphasized in the previous day’s lesson. Even though a preview of new material can be as simple as the modeling and choral repetition of new vocabulary items, this kind of brief introduction will give students a head start.

A general sequence to follow in planning each class would be review → new material (main emphasis) → preview of new material. The sample lesson plans in this section of the Manual and the charts in the next section follow this sequence.

## 2. Write Down Your Plan

Check your plan to see that you have a variety of classroom activities, as well as a balance of the language skills and cultural material appropriate to your course. Is there an opportunity for students to talk with each other in Spanish, as well as with you? Have you planned enough activities for the entire class hour? Many experienced instructors always have one extra exercise or activity prepared, just in case they finish a little early—a listening comprehension passage, a guessing game, a grammar review exercise, a conversation activity, and so on.

Remember to make an assignment for the next class. Many students appreciate being given very specific assignments such as those listed in the sample lesson plans in this section of the Manual. When clear, regular assignments are given along with frequent quizzes, students are more likely to keep up with their work on a day-to-day basis.

## 3. Prepare Your Materials

Some instructors write down every detail of their plans on index cards; others jot down most of their teaching notes in the margins of their books, and still others use a teaching notebook or a folder. After you have written down your plan, prepare the handouts, visuals, or transparencies you want to use, and then review your plan and materials one last time to make sure that everything fits together: Does every exercise have a purpose? Has anything important been omitted? How much time do you want to devote to each segment of the class? Have you planned a few minutes of review? Will most of the class hour be spent on the material you want to emphasize? Have you reserved a few minutes of the class for a preview of tomorrow's material? This kind of planning will help students learn and provide links between classes.

## 4. Evaluate Your Class Session

What went well? Why? What didn't go so well? Why not? Would a slight change improve an explanation or an exercise? Should a particular exercise or activity be omitted? A few brief notations made on this term's plan will remind you to make the necessary changes next term or next year.

## C. USING THE SUGGESTIONS IN THE *INSTRUCTOR'S EDITION*

The suggestions and supplementary exercises in the *Instructor's Edition* are intended to save you planning time. The sample lesson plans in this Manual will show you how to incorporate the suggestions and exercises into your lesson plans for the first chapters of the text. Suggestions and exercises fall into several categories and are labeled for easy use and application.

### 1. Suggestion

A suggestion presents one way to introduce material or use an exercise in class. It is by no means the only way to use text material, but it may give you some good ideas. For example, the suggestions on the first page of the bound-in supplementary materials of the *Instructor's Edition* give you a sequence to follow in presenting the first minialogues in the text: introduction, modeling, choral repetition, individual repetition, and small groups.

## 2. Extension

An activity extension provides several more items of the same type as the items in student text exercises, to afford more practice. When an exercise has been assigned as homework, you may want to use only the first few items in the student text and then skip to the extension items in the *Instructor's Edition* to make sure that students have mastered the material.

Another advantage to the extension items is that they provide listening comprehension practice. An example is on page 147.

## 3. Variation

This suggests using the activities in a different way than the instructions in the student text. An example is on page 120.

## 4. Note

This information is intended for you. You may or may not want to pass it on to your students, depending on the information and your particular course goals. An example of this kind of additional information is on page 37.

## 5. Follow-Up

These additional activities are intended for use after related activities in the student text. They may be entirely new, often personalized activities related to nonpersonalized ones or communicative activities related to precommunicative ones. An example is on page 33.

## 6. Preliminary Exercises

This kind of very focused exercise usually precedes an exercise in the student text on a given grammar point. These are often mechanical verb drills, pattern practice, discrimination exercises, or listening exercises. For example, the preliminary exercises that precede the **-ar** verb exercises on page 36 give students focused practice with personal endings and listening comprehension.

## 7. *Reciclado*

This review activity gives students additional practice with material covered in earlier chapters. These are always preceded by the round recycling icon. An example is on page 32.

## 8. *Refrán*

These annotations are new to the Second Edition, after many instructors requested that popular sayings and proverbs be included. **Refranes** were selected based on difficulty and relationship to the chapter's vocabulary and grammar. An example is on page 96.

## 9. Bright Idea!

New to the Second Edition, these suggestions or activities come directly from professors and instructors currently using *Puntos en breve* across the country. We are immensely grateful that they contributed their valuable ideas to the Second Edition. An example is on page 118.

## D. SAMPLE LESSON PLANS

This section of the Instructor’s Manual offers sample lesson plans for **Ante todo** and **Capítulo 1** for classes meeting five hours per week (five to six contact hours available per core chapter). These plans assume that instructors require students to use the Workbook/Laboratory Manual. Assignments for the audio program are not given here.

### LESSON PLANS: ANTE TODO (OVERVIEW)

The brief overview offered with each day’s suggested lesson plan lists the major topics suggested for main focus on that day. You will note that, by and large, major sections of each chapter receive in-class focus in the same sequence of presentation as in the textbook.

It is possible, of course, to cover materials in a different sequence, but you will find that adjustments in content may be needed. In particular, if you choose to introduce a section earlier than when it is presented in the text, it may be necessary to introduce some prerequisite knowledge first.

### 1. *Ante todo*: First Day

Overview: Introductions <b>Saludos y expresiones de cortesía</b>
---

1. Greet students, saying **Buenos días/Buenas tardes/Buenas noches**, as appropriate, offering a handshake. Then have students greet other students who are sitting near them. (2 min.)
2. Introduce yourself and the course (see also “Teaching Techniques: The First Day of Class,” Section III in this Manual). (5 min.)
3. Getting to know students (5 min.)  
Have students fill out information sheets: name, high school attended, local address and phone number; languages studied in high school or college and for how long; class rank and major; foreign study, work, or travel—where and for how long. Discuss some of the data, if appropriate.
4. **Primera parte: Saludos y expresiones de cortesía (1)** (p. 2) (8 min.)
  - a. Introduce the topic of the first **minidiálogo**: how to greet and take leave of friends.
  - b. Point out: the English equivalents of minialogues always appear at the bottom of the page.
  - c. Model the minialogue.
  - d. Elicit multiple choral repetitions, followed by individual repetitions.
  - e. Do a small-group practice: students pair off and practice the minialogue, reverse roles, and then repeat the dialogue, using their own names.

5. **Saludos y expresiones de cortesía (2)** (p. 2) (8 min.)
  - a. Introduce the topic: how to greet and take leave of people you don't know well.
  - b. Model the minidiologue.
  - c. Discuss familiar (first-name basis) relationships versus formal (last-name) relationships.
  - d. Do multiple choral repetitions followed by individual repetitions and pair practice.
6. **Saludos y expresiones de cortesía (3)** (p. 2) (8 min.)
  - a. Introduce the topic: one way to ask a person's name, and how to respond when meeting someone for the first time.
  - b. Model, then do multiple choral repetitions, followed by individual repetitions.
  - c. Ask several students: **¿Cómo se llama Ud.?** (formal) versus **¿Cómo te llamas?** (familiar). Have students use the familiar form with each other, the formal with you. Also point out the appropriate responses when meeting someone for the first time: **Mucho gusto. Encantado/a.** Possible rejoinder: **Igualmente.**
  - d. Do a chain drill: The first student in the front row turns to the next student and asks: **¿Cómo te llamas?** The student answers: **Me llamo \_\_\_\_\_.** The first student responds: **Mucho gusto (Encantado/a).** The second student then turns to the next student in the row and asks the same question. When students get to the end of the row, try to recall all their names.
7. **Saludos y expresiones de cortesía (4)** (p. 2) (8 min.)
  - a. Introduce the topic: one way to ask a person's name and find out where he or she is from.
  - b. Model, then do multiple choral repetitions, followed by individual repetitions.
  - c. Ask several students: **¿De dónde es usted?** (formal) versus **¿De dónde eres?** (familiar). Have students use the familiar form with each other, the formal with you. Also point out the phrase **¿Y usted?** and **¿Y tú?** for returning the question.
  - d. Do a chain drill: The first student in the front row turns to the next student and asks: **¿De dónde eres?** The student answers: **Soy de \_\_\_\_\_.** **¿Y tú?** The first student responds: **Soy de \_\_\_\_\_.** The second student then turns to the next student in the row and asks the same question. When students get to the end of the row, try to tell where each one is from: **Marcos, usted es de...**
8. Preview **El alfabeto español** (p. 5) (4 min.)
  - a. Point out: extra letters in the Spanish alphabet: **ñ, rr.**
  - b. Model letters, followed by choral repetition and individual repetition.
9. Assignment (on board)
  - a. Review: **Saludos y expresiones de cortesía 1, 2, 3, 4** (pp. 2–3).
  - b. Read: **Nota comunicativa: Los cognados** (p. 6) and **Nota cultural: Spanish in the United States and in the World** (pp. 8–9).

## 2. *Ante todo:* Second Day

Overview: **Nota comunicativa: Otros saludos y expresiones de cortesía**  
**El alfabeto español**  
**Nota comunicativa: Los cognados**  
**¿Cómo es usted?**  
**Nota cultural: Spanish in the United States and in the World**

1. Warm-up/Review (4 min.)
  - a. Review greetings.
  - b. Review **¿Cómo se llama Ud.?** and **¿De dónde eres?**
2. **Nota comunicativa: Otros saludos y expresiones de cortesía** (p. 3) (10 min.)
  - a. Introduce the topic: variations of greetings already learned.
  - b. Use model, choral repetition, individual repetition pattern.
  - c. Point out mealtimes (optional note).

- d. Have students greet each other using **señor/señorita/señora** with the last name and an appropriate time expression: **Buenos días/Buenas tardes/Buenas noches**.
- e. Do **Conversación A** through **D** (p. 4).
3. **El alfabeto español** (p. 5) (8 min.)
  - a. Practice the alphabet.
  - b. Practice pronunciation of the names in the list: model, choral repetition, individual repetition.
  - c. Do a spelling dictation.
  - d. Ask **¿Cómo se llama usted?** Have students answer and spell their names: **Me llamo Juan: jota - u - a - ene**.
  - e. Do **Práctica A** and **B** (p. 6).
4. **Nota comunicativa: Los cognados** (p. 6) (6 min.)
  - a. Present concept of cognates.
  - b. Point out: spelling equivalents (*-ent* versus *-ente*, and so on), following the examples.
  - c. Model adjectives, followed by students' repetitions.
5. **¿Cómo es usted?** (p. 7) (10 min.)
  - a. Model singular forms of **ser**, then do choral repetition, individual repetition.
  - b. Point out: the concept of familiar (**tú eres**) versus formal (**usted es**) already discussed in greetings.
  - c. Do **Conversación** (p. 7) using cognates presented on p. 6.
6. **Nota cultural: Spanish in the United States and in the World** (pp. 8–9) (8 min.)
  - a. Ask: Where is Spanish spoken? Students answer using the names of Spanish-speaking countries from the map (p. 8). Write names of the countries on the board as students give them.
  - b. Point out: (1) There are more than twenty Spanish-speaking countries with 425 million speakers; (2) Spanish is the third most widely spoken language in the world.
  - c. Model names of the countries, followed by student repetition.
7. Preview **Los números 0–30; hay** (p. 12) and **Gustos y preferencias** (p. 14) (4 min.)
  - a. Preview numbers by counting out loud with students: 1 to 10, then 1 to 20, then 1 to 30.
  - b. Preview **gustar** by using objects or drawings that you have brought to class.
8. Assignment (on board)
  - a. Review: **Notas comunicativas: Otros saludos y expresiones de cortesía** (p. 3) and **Los cognados** (p. 6), and **¿Cómo es usted?** (p. 7).
  - b. **Pronunciación: Las vocales** (p. 10), **Los números 0–30; hay** (p. 12), and **Gustos y preferencias** (p. 14).
  - c. Write: the exercises for **Ante todo: Primera parte** in the Workbook/Laboratory Manual (pp. 1–3).

### 3. *Ante todo: Third Day*

Overview: **Pronunciación: Las vocales**  
**Los números 0–30; hay**  
**Gustos y preferencias**

1. Warm-up/Review (7 min.)
  - a. Greet students, using all expressions of courtesy and titles.
  - b. Review **Nota comunicativa: Otros saludos y expresiones de cortesía**.
  - c. Review the Spanish alphabet.
  - d. Review **¿Cómo es usted?** and cognates. Ask: **¿La clase es interesante/importante/eficiente/terrible?**, using cognate adjectives from p. 6.
2. **Pronunciación: Las vocales: a, e, i, o, u** (p. 10) (10 min.)
  - a. Introduce Spanish vowel sounds as compared with English vowel sounds (p. 10).
  - b. Use model, choral repetition, individual repetition pattern.
  - c. Do **Práctica A, B, C, and D** (pp. 10–11): model, choral repetition.

3. **Segunda parte: Los números 0–30; hay** (p. 12) (16 min.)
  - a. Introduce the topic: a typical child’s song from the Spanish-speaking world.
  - b. **Canción infantil:** model, choral repetition, individual repetition.
  - c. Present 0–30 with flash cards (5 × 8 file cards or half sheets of paper). Choral repetition as you point to numbers. Point out written accents on **dieciséis, veintidós, veintitrés, veintiséis**, and the change from final **-e** in **veinte** to **-i** (**veinti-**).
  - d. Do **Práctica A** and **B** (p. 13). Follow up with more math problems, given orally.
  - e. Do **Conversación** (p. 13).
4. **Gustos y preferencias** (p. 14) (12 min.)
  - a. Use objects or drawings that you have brought to class, in addition to those used when previewing **gustar** during the previous class session. Holding the appropriate item, say, **Me gusta el café. No me gusta la Coca-Cola**. Make appropriate facial expressions to accompany the model sentences. Use the question form (**¿Le gusta el café?**) to elicit full-sentence answers from several students.
  - b. Present the concept of **gustar** (p. 14). Write model sentences on the board as you give the explanation.
  - c. Model **Me gusta la clase / No me gusta la clase** (and other appropriate cognates); do choral repetition.
  - d. Do **Conversación A** on p. 14, asking questions of individual students while indicating possible model answers on the board.
  - e. Have students do **Conversación B** (p. 15), working in pairs.
5. Preview: **¿Qué hora es?** (pp. 15–16) (5 min.)
  - a. Draw a clock face on the board.
  - b. As you draw the hour and minute hands, model the question **¿Qué hora es?** and the answer **Son las dos (las tres, and so on)**.
6. Assignment (on board)
  - a. Review: **Pronunciación: Las vocales** (p. 10), **Los números 0–30; hay** (p. 12), and **Gustos y preferencias** (p. 14).
  - b. Read: **¿Qué hora es?** (pp. 15–16) and **Lectura: La geografía del mundo hispánico** (pp. 18–19).
  - c. Write: the exercises for **Los números 0–30; hay** and **Gustos y preferencias** in the Workbook/ Laboratory Manual (pp. 6–8).

#### 4. *Ante todo:* Fourth Day

Overview: **¿Qué hora es?**  
**Lectura: La geografía del mundo hispánico**

1. Warm-up/Review (10 min.)
  - a. Review **Los números 0–30, hay**. Give math problems orally, as in **Práctica B**, p. 13. Ask: **¿Hay treinta días en una semana? (¿diecinueve, dieciocho, doce, veintisiete?) ¿Hay veinticuatro estudiantes en la clase?**
  - b. Review **gustar** and cognates. Ask individual students what they like or don’t like, prompting them with cognates.
2. **¿Qué hora es?** (pp. 15–16) (15 min.)
  - a. Introduce ways of telling time. Model pronunciation in examples, followed by student repetition.
  - b. Introduce **Nota comunicativa: Para expresar la hora** (p. 16). Model expressions.
  - c. Do **Práctica A** (p. 16) and **B** (p. 17).
  - d. Do **Conversación A** and **B** (p. 17).

3. **Lectura: La geografía del mundo hispánico (Parte 1)** (pp. 18–19) (20 min.)
  - a. Go over the **Estrategia**.
  - b. Ask students what they already know about geography in different Spanish-speaking countries. Describe the photos in Spanish in random order, and have students identify which one you are describing. For example, **Hay muchas montañas en Chile**.
  - c. Have students do the reading out loud and help them with pronunciation.
  - d. Remind students about the significance of the underlined words. Go over the first such words with them.
  - e. Go over the reading section by section, asking brief **sí/no** comprehension questions like **¿Hay pampas en la Argentina?**
  - f. Do **Comprensión** (p. 19).
4. Assignment (on board)
  - a. Review all of **Ante todo**.
  - b. Complete the Workbook/Laboratory Manual section for **Ante todo**.

### 5. *Ante todo*: Fifth Day

Overview: **Test**  
**Preview of Capítulo 1**

1. Warm-up/Review (10 min.)
  - a. After greeting students, ask a variety of questions covering the different topics of **Ante todo**, such as **¿Qué hora es? ¿A qué hora es la clase? ¿Te gusta la clase de español? ¿A qué hora es el programa de televisión *Los Simpson* (*Friends...*)?**
  - b. Offer students a chance to ask questions about material in **Ante todo**.
2. Test (30 min.)
3. Preview: Overview of **Capítulo 1** (10 min.)
  - a. Point out: *Puntos en breve* has a regular chapter structure beginning with **Capítulo 1**.
  - b. Introduce the theme and grammar structures of the chapter, focusing on the opening page (p. 21).
4. Assignment (on board): Read **Vocabulario: Preparación** (p. 22).

- Warm-up/Review (5 min.)
  - Greet students, using all expressions of courtesy and titles possible for the class.
  - Review telling time, **gustar** questions, and questions with interrogatives.
- Vocabulario: Preparación: En la clase** (p. 22) (8 min.)
  - Reenter vocabulary: model, choral repetition, individual repetition.
  - Hold up classroom items, point to other items; use **¿Qué es esto?** / **¿Quién es?**, as appropriate.
  - Do **Conversación A, B** (p. 23).
- Nota cultural** (p. 24) (3 min.)
  - Ask students what they know about Hispanic education and universities.
  - Help students with the pronunciation of the university names. Ask if they have heard of any of these before.
- Vocabulario: Preparación: Las materias** (p. 24) (12 min.)
  - Introduce **Las materias** (p. 24): model, choral repetition, individual repetition.
  - Do **Conversación A** (p. 25).
  - Introduce **Nota comunicativa: Palabras interrogativas** (p. 25).
  - Do **Conversación B** (p. 25).
- Pronunciación: Diphthongs and Linking** (p. 27) (10 min.)
  - Review vowels: **a, e, i, o, u**. Do Exercise **A** (p. 27).
  - Introduce the concept of diphthongs. Do Exercise **B** (p. 27).
  - Stress the importance of linking. Do Exercise **C** (p. 27).
- Preview: **Gramática 1: Singular Nouns: Gender and Articles** (pp. 28–30) (12 min.)
  - Introduce the topic.

Students may answer only for the students they talked with, not for themselves. For example, Ana may answer, **Linda habla italiano.**
