Of the many federal initiatives in the area of health care, HIPAA has arguably had the widest effect on those working in allied health. HIPAA aims to enforce national standards for the health care information that is communicated while also protecting information privacy. Its concepts affect health care claims, electronic health records, and all other forms of communication in the delivery of health care.

HIPAA for Allied Health Careers is specifically designed to teach the concepts and knowledge allied health workers must understand to correctly handle patients' protected health information (PHI) and to comply with all HIPAA regulations, including:

- **>** Administrative Simplification
- > Privacy Rule
- > Security Rule
- Transactions, Code Sets, and National Identifier Standards
- Final Enforcement Rule and Compliance to Avoid Fraud and Abuse


Chapter 1, *The Goal of HIPAA: Administrative Simplification*, overviews the reasons for the federal legislation and why the rules are critically important.


