# Preface

he title *A Child's World* reflects our vision of the study of child development as an exciting journey of exploration into the special world of childhood and our desire to make that world come alive. By studying this book, students will gain a perspective, not only on what earlier explorers have discovered about children's development, but also on how the world looks from a child's viewpoint.

# Our Aims for This Edition

Although the design, content, and features of *A Child's World* have changed dramatically since the first edition, a consistent goal has been to emphasize the continuity of development and its contrasts across cultures; to highlight interrelationships among the physical, cognitive, and psychosocial domains; and to integrate theoretical, research-related, and practical concerns. In this twelfth edition our primary aim is to build on these foundations by revising and adding much new material while keeping the overall size manageable. We have cut redundancies and streamlined features to make navigation through the chapters easier for students.

# Cutting-Edge Research

We have sifted through the plethora of literature published each year to select cuttingedge theory and research that will add significantly to students' understanding.

We have broadened the research base of each chapter and have updated throughout, using the most current statistics available. We have striven to make our coverage as concise and readable as possible while still doing justice to the vast scope and significance of current theoretical and research work.

#### **Cultural Influences**

This edition continues our stress on cultural and historical influences on development. Reviewers have praised our emphasis on culture as a particular strength of this book. Cross-cultural research is fully integrated throughout the text as well as highlighted in Around the World boxes, reflecting the diversity of the population in the United States and in other societies.

# The Twelfth Edition at a Glance

# Organization

This book takes a *chronological* approach, describing all aspects of development at each period of childhood. With this approach students gain a sense of the multifaceted sweep of child development. The 17 chapters fall into six parts:

• Part 1 summarizes the history, basic concepts, theories, and research tools of the field of child development.

- Part 2 describes the beginnings of life, including the influences of heredity and environment, pregnancy and prenatal development, birth, and the newborn baby.
- Parts 3 through 6 are divided into three chapters each, covering physical, cognitive, and psychosocial development during infancy and toddlerhood, early childhood, middle childhood, and adolescence.

# **Pedagogical Features**

We are gratified by the overwhelmingly favorable response to the pedagogy we have developed for *A Child's World*, which includes the following features:

- Our comprehensive Learning System, a unique, coordinated set of elements that work together to foster active learning. The names of the pedagogical features (Guideposts, Checkpoints), and critical thinking questions (What's Your View?) are designed to reinforce our central theme of exploration and discovery of a child's world.
- Guideposts for Study This list of questions at the beginning of each chapter highlights the key concepts to learn. Each Guidepost appears again to introduce the related text section.
- *Checkpoints* These questions placed in the margins throughout each chapter serve to help students assess how well they grasp the concepts in the preceding text sections.
- What's Your View? These critical thinking questions, placed in the margins throughout each chapter and in the boxed features, encourage students to examine their thoughts about the information presented in the text.
- Summary and Key Terms Concluding each chapter, these resources, organized under the Guideposts, help students review the chapter and check their learning.

Each part of the book begins with a distinctive, illustrated two-page spread containing the following features:

- · Part Preview, which outlines the highlights of each chapter
- Part Overview, which introduces important themes of the chapter
- Linkups to Look For (in Parts 2–6), which provides examples of interaction among the physical, cognitive, and psychosocial domains of development

A new feature, Did You Know . . . ?, introduces each chapter by highlighting interesting and enlightening findings mentioned in the chapter. A Landmark Table in the endpapers helps students find the whole child at each period of development as well as trace various domains of development across childhood and adolescence.

Three types of boxes enhance our text by highlighting topics related to the main text.

- *The Research World* boxes provide an in-depth examination of research topics briefly mentioned in the text. For example, you will find a new Research World box on Family Mealtimes and Child Well-Being (Chapter 14).
- The Everyday World boxes deal with a variety of practical applications of research. This edition offers new Everyday World boxes on Food Security (Chapter 9) and Multitasking and Gen M (Chapter 16).

• Around the World boxes explore the way an issue in the chapter is treated or experienced in one or more foreign cultures, or in a United States minority group. New Around the World boxes are included on Children of Immigrant Families (Chapter 1) and Inventing Sign Language (Chapter 7).
